## OCTOBER IS DOMESTIC VIOLENCE AWARENESS MONTH THIS SHOULDN'T BE A RINGSIDE SEAT...



"I didn't want to be blamed to tearing the family apart."

"I told him I wanted a divorce and he yelled that he'd keep the kids and never let me see them again."

Children often get trapped in the middle of violence and abuse between parents. They are exposed to the devastation of emotional, verbal, and physical abuse in their homes.

Abusive relationships employ manipulation and fear to keep a partner from leaving because of fear of "losing" access to children or destroying the family structure. But staying in abuse "for the kids" causes children to experience trauma.

At Stepping Stones, we view children as PRIMARY victims of abuse, even though they may not be directly physically or sexually assaulted. The welfare of child victims takes precedence over all other responses.



Children who witness abuse are considered PRIMARY victims at Stepping Stones. The effects of abuse can impact their mental and emotional development long after the abuse is gone from their lives. Call our advocates if you need help: 928-445-4673.

What does this mean? It means that adult victims and offenders are held accountable in the areas that affect the welfare of children involved. It's the responsibility of adults to ensure that their children are safe and cared for. When abuse is present, children are not safe, even if they are only witnessing what is happening.

We strive to empower adult and child victims by providing unconditional, non-judgmental, supportive, and therapeutic responses to the abuse they've experienced. For adults, these responses will be rigorously truthful, however difficult, so that they can have all information necessary to make healthy choices and truly make significant changes in their lives and the lives of their children.

#### **LEAVING ABUSE BEHIND FOR GOOD**

A key part of truly finding freedom from all forms of abuse is sheding any victim postures and taking an honest self-inventory in order to address behaviors and trauma that is keeping someone vulnerable to abuse. At Stepping

Stones, our advocates help adults take a look at these areas and help families take control of areas in life they can control, and learn to let the rest go.

Adults who have participated in Stepping Stones programs are

asked to take an anonymous survey upon completion of the program to provide feedback on how they feel their lives have improved since graduating. From January - June 2020, those who participated shared:



#### 100% reported:

They have increased knowledge of domestic violence and its effect on their lives.

They have increased knowledge and understanding of violence, abuse, and neglect's effect on their child's life.

They are confident they will remain free from abuse when they leave SSA.

They feel their safety has improved, even after leaving SSA.

#### SUPPORT LOCAL FAMILIES WITH AN ARIZONA TAX CREDIT DONATION

What does it mean to give a dollars go AND make a difference 2020 AZ Qualifying Charitable Organization Tax Credit donation to Stepping Stones? It means families are able to find freedom from all forms of abuse right here in our community.

Arizona offers a dollar-for-dollar tax credit by making a donation gualified charitable to organization of any amount (up to \$400 filing single or \$800 filing joint on your AZ state return). When you claim the credit on your state return, you will reduce your tax liability or increase the amount you receive in a refund. You do not have to itemize to receive this credit.

You can choose where your tax


