HELP FAMILIES SPEAK UP AND BREAK THE SILENCE WITH YOUR TAX CREDIT DONATION GIFT

Families can enjoy the holiday season safely because Stepping Stones advocates are available 24/7/365 and have been for 40 years. Our around-the-clock services are supported by our amazing community who shop with us at Stepping Stones Thrift Stores and give - whether \$25 or \$5,000, you are the reason we are here.

You can be a part of it by giving a 2020 AZ Qualifying Charitable **Organization Tax Credit donation** to Stepping Stones. Arizona offers a dollar-for-dollar tax credit by making a donation to a qualified charitable organization of any amount (up to \$400 filing single or \$800 filing joint on your AZ state return).

When you claim the credit on your state return, you will reduce your tax liability or increase the amount you receive in a refund. You do not have to itemize to receive this credit.

Make a difference in the lives of local families working hard to find freedom from all forms of Prescott Valley, AZ 86314 victimization by keeping your tax dollars local!

SPEAKING UP AND FINDING SAFETY



Breaking the silence includes learning how to stay safe in the future. From understanding the dynamics of violence to knowing how to plan for safety, families at Stepping Stones are able to learn to live free from all forms of abuse. Adults in our programs take an anonymous survey upon exit to provide feedback. From Jan 1- September 30, 2020, those who participated shared:

100% reported they feel they are regaining control in their life.

98% reported they feel their safety improved, even after leaving Stepping Stones

100% reported they have an increased knowledge of domestic violence and its effect on their lives.

97% reported they are completing their goals.

100% reported they know how to plan for their continued safety.

HELP OUR THRIFT STORES STAY OPEN: MASKS AND SOCIAL DISTANCING REQUIRED

Our thrift store team is surfaces are disinfected working hard to operate our stores safely as our community navigates the COVID-19 pandemic. We have implemented the CDC and state recommended mitigation procedures, but we need your help to ensure that our doors stay open for shopping and donating.

Please remember to always wear a mask when you visit our stores and keep at least **6 feet distance** between you and others when possible. Our team is doing their part, too. They are wearing masks, cleaning our stores hourly to ensure that high touch

regularly, and all donations are sprayed and disinfected. Thank you for continuing to come in and shop with us - you are helping us ensure our doors are open for local families who are experiencing violence and abuse in our community. We would not be able to do this without you, and we need you help to keep it going!
