SERVING AND SUPPORTING CHILDREN



At Stepping Stones, children are considered PRIMARY victims of abuse, even if they are not directly physically or sexually assaulted. Why? Because we know the affect witnessing abuse can have on a child. Our Children's Advocate spends time working with all ages of children who come into our shelter providing support and helping them work on their own safety and emotional experience. Adults in our programs take an anonymous survey upon exit to provide feedback. From Jan 1- Dec 31, 2020, those who participated shared:

100% reported they have increased knowledge about violence, abuse, and neglect's effects on their child's life.

100% reported their child has practical knowledge of how to use their safety plan.

100% reported their child has acquired skills that will enable them to keep themselves safe.

100% reported their child has improved emotional/ behavioral status since arriving at Stepping Stones.

GIVE YOUR ARIZONA CHARITABLE ORGANIZATION TAX CREDIT DONATION TODAY!

Arizona extended their individual tax filing deadline for 2020 to match the Federal deadline - May 17. Plus, Arizona just shared that they have also extended the Qualified Charitable Tax Credit donations for 2020 to May 17, too!

This special dollar-for-dollar tax credit allows you to make a donation to Stepping Stones and receive a credit on your state taxes (up to \$400 filing single and up to \$800 filing married/joint).

How it works:

- 1. Make a donation to Stepping Stones in the amount you choose by May 17, 2021.
- 2. We'll send you a receipt *credits here*: 20034.

3. Use AZ form 321 when you file your taxes to claim the credit.

That's it! Your tax dollars stay local and support families finding freedom from all forms of abuse right here in your community.

"When we find ourselves something wanting strong enough, we'll do just about anything to get it - sometimes at the expense of our bodies, brains, bank accounts. and relationships. why do we sometimes have the irrepressible feeling that we need something—such as food, cigarettes, alcohol, or sex--that we really just want?"

Dr. Omar Manejwala is a nationally recognized expert on compulsive behaviors who explains the phenomenon of craving and gives us tools to achieve freedom from our seemingly insatiable desires

by changing our actions to remap our brains. "A good working definition of 'craving' is a strong desire that, if unfulfilled, produces a powerful physical and mental suffering." (p.2)
